

AFFILIATE CONTRIBUTOR OF THE YEAR AWARD

This award is designed to honor an active member of the AARC, who through their tireless contribution of time and effort provides the most significant contribution to the goals of the New York State Society for Respiratory Care (NYSSRC) in a two calendar year period.

GENERAL CRITERIA:

1. Must be an active member of the AARC.
2. All work considered must be from the preceding two (2) years.

SPECIFIC CRITERIA:

1. Demonstrated significant achievement in one or more of the following areas in the preceding two (2) years:
 - a) Offices held during the calendar year from the preceding two (2) years.
 - b) Committee Chair activities.
 - c) Committee Member activities
 - d) Activities at the national level in AARC
 - e) Activities that relate to respiratory care
 - f) Activities at the affiliate region level
 - g) Activities on the Ad Hoc level and committee, taskforces
 - h) Other duties delegated by the NYSSRC Board of Directors

NOMINATIONS:

1. Nominations must come from an active member of a region or NYSSRC Board of Directors (BOD).
2. A NYSSRC BOD member and two (2) other active members of the AARC should write a letter of initial sponsorship, nomination and recommendation documenting the contributions and achievements of the nominee.
3. A C.V. of the nominated member must accompany the nomination letters.
4. All nominations, CVs, and letters of support should be received by **MARCH 1**.
5. All nominations shall be reviewed and voted upon by the Awards Committee using pre-established criteria, and the chosen candidate will be ratified at the 2nd quarter NYSSRC BOD meeting via acceptance of the committee report.
6. The NYSSRC will pay for 1 night lodging, 1 day per diem expense, registration and travel expenses for the recipient.
7. Forward all nominations and letters of support to: NYSSRC Awards Committee.
